

# Dawgs in Motion On Site Training Agreement

Please read and initial in each box listed below and review terms and conditions on the back. Forms must be initialed, signed, and returned to Dawgs in Motion no less than one day prior to your session with a trainer.

- I understand that to participate my dog must be current on Rabies (at 16+ weeks old), Distemper, and Bordetella.
- I understand that to participate in the class I must have a current customer policy in addition to my vaccinations and this training agreement on file at Dawgs in Motion.
- I understand that I must bring a standard 4-8ft leash that is NON-RETRACTABLE.
- I understand that I must provide a variety of 2-3 types of training treats for my dog during **group classes**.  
*Failure to do so will result in a \$2.00 +tax charge being added to my account for the provision of training treats.*
- I understand that I must provide a variety of training treats for my dog during **camp private lessons** and that  
*failure to do so will result in my session being terminated with no refund.*
- 3-week GROUP CLASSES (On Leash)  
3-week group classes will meet once a week for 3 consecutive weeks on the same day of the week and at the same time each class. Students will receive a completion certificate at the end of the course. Students must attend all 3 classes in order to receive the certificate. Make up classes may be scheduled at the cost of a private lesson.
- 6-week GROUP CLASSES (On Leash)  
6-week group classes will meet once a week for 6 consecutive weeks on the same day of the week and at the same time each class. Students will receive a completion certificate at the end of the course. Students must attend all 5/6 classes and pass the final exam at the end in order to receive the certificate. Make up classes may be scheduled at the cost of a private lesson.
- 1 Night ELECTIVE CLASSES (On Leash)  
One-night elective classes are a single night class. These courses do not receive a graduation certificate.
- PUPPY SOCIALIZATION CLASSES  
Class will not be cancelled even if only one puppy signs up. The class will still be instructed for socializing to humans, textures, sounds, etc. and the obedience portion still instructed. The owner may agree to socializing with an adult demo dog if one is available.
- The owner is required to work the dog a minimum of 7 times a week on strengthening all cues taught. The reinforcement can be accomplished in approximately 20 to 30 minutes per day or in two 10–15-minute sessions.
- I understand that Dawgs in Motion's Certified Dog Trainers are balanced method trainers that follow the L.I.M.A (Least Intrusive Minimally Aversive) standard of training. I understand that the trainers may use a variety of tools to find the best fit for my pet based on their behavior, this may include but is not limited to: flat buckle collars, martingale collars, prong collars, E-Collars, front clip harnesses, head collars (Gentle Leader, Halti, etc.), Weiss Walkie style leashes or body wrap leashes, etc.



## TERMS & CONDITIONS

### GAURENTEES

I understand that Dawgs in Motion cannot make any guarantee regarding the outcome of any training/counseling program. I, as the owner or agent of the above listed pets, assumes full responsibility for the pet's behavior before, during, and after the training/counseling program.

### PACKAGES

I understand that Dawgs in Motion provides the option to purchase a package for training. I understand that these packages are non-refundable and are also non-transferrable.

### CANCELLATIONS

I understand that cancellation of my lesson must be given within 24 hours' notice (1 days prior to lesson) to Dawgs in Motion. Failure to notify within the 24-hour time frame will result in a cancellation fee of 50% of the quoted cost unless otherwise approved by management.

### EQUIPMENT

I understand that the trainers at Dawgs in Motion are considered Balanced (L.I.M.A.) trainers. I also understand that the trainer may recommend tools or equipment to use in conjunction with my pets' training and I as the owner/agent of the pet will be responsible for purchasing all necessary equipment that the trainer recommends.

### AGGRESSIVE BEHAVIOR

I understand that any aggressive behavior demonstrated by my pet(s) may result in termination from the training program. I also understand that based on the severity of the aggression my pet(s) may also be removed from other Dawgs in Motion services.

### LIABILITY

As the legal owner/agent of the above-mentioned pet(s), having carefully read and fully understand this agreement, do hereby waive and release Dawgs in Motion and all affiliates from all liability of any nature. This includes any injury, death, sickness or damage to myself, my pet, or any property before, during, or after any training. I also agree to indemnify and hold harmless Dawgs in Motion and all affiliates from all claims due to damage the pet may cause to any third parties before, during, or after training.

### TERMINATION OF TRAINING

I understand that as the owner/agent of the above listed pet(s) that I may withdraw from training at any time, however, the day that training starts, or once training has begun all fees are non-refundable.
