Be aware that there are times that some of the campers are placed in kennels/crates during their stay with us.

Dawgs in Motion LLC reserves the right to limit a dog's time in daycamp due to behavior/health issues.

- All dogs will be evaluated for temperament during their service at our facility. Each daycamp/nightcamp dog's owner will receive an evaluation sheet. Dawgs in Motion LLC reserves the right to deny or refuse a dog or limit their play because of a safety issue with other dogs or employees. Dogs can be denied for people or dog aggression, anti-social or physical illness.
- All dogs entering and exiting the Dawgs in Motion LLC facility must be on a leash (non-flexible) or in a travel kennel and wearing a flat quick release collar (not a break away collar). Dogs may enter on a training collar as long as they also have quick release collar.
- All dogs being fed in our facility are required to have pre-packaged food with their name and date on it. There will be a fee if food is not pre-packaged for nightcamp stay.
- All fees of services are due upon the completion of the service. Our Night Camp service requires a deposit to hold the reservation spot. Acceptable forms of payment are gift cards, debit cards, credit cards (MC/VISA/Discover, Amex), check, or cash.
- Packages need to be purchased prior to the service used.
- There will be a \$7.00 fee charged for late pick-ups after closing time for daycampers. Dawgs in Motion LLC closes at 6pm on Monday thru Friday and 4pm on Saturday and Sunday. If you arrive after we close and before 7pm you will need to wait until 7pm until we are open for late pick ups. Late pick up times are from 7pm to 7:30pm.
- For Night Campers – there will be a \$20 fee for reservations made the day BEFORE OR THE DAY OF drop off and a \$25 fee if making a reservation the day BEFORE OR THE DAY of drop off for a holiday – PER DOG.
- For Night Campers – there will be a cancellation fee of \$35.00 (per dog) if a reservation is cancelled at any time.
- For Night Campers - the fee for the reservation will be paid in full by the customer even if the dog is picked up earlier than the original reservation, with the exception of any activities not completed.

Dawgs in Motion LLC, its owners, employee's or any other person(s) affiliated with the company shall hereinafter be referred to as in "Dawgs in Motion LLC." You shall hereinafter be referred to as "client". Dawgs in Motion is not responsible for any damage to items during the pet's stay. Note that Dawgs in Motion LLC will do everything in their power to keep all items safe and secure during the stay. All items that are brought in with the pet should be clearly and permanently marked by the owner (client).

The owner (client) understands that they are responsible for any damage the pet does to Dawgs in Motion LLC property.

I hereby declare that my dog has not been exposed to any communicable diseases within the 30 days and is fully vaccinated in accordance to Dawgs in Motion LLC policy.

In signing the form I grant Dawgs in Motion LLC, its legal representative and assigns, the absolute right and permission to use, re-use and publish and republish pictures photographed at any time that my dog is at Dawgs in Motion LLC without further permission or compensation to me. All images shall constitute the property of Dawgs in Motion LLC solely and completely. I assure that this form is completed to the best of my knowledge. I understand the hours of operation of Dawgs in Motion and the night camper pick up and drop off-hours and cancellation policy. I accept the terms, condition and policies of Dawgs in Motion LLC set forth by this agreement. **All clients agree not to hold Dawgs in Motion LLC liable or sue for any injury and/or death to your dog(s) while in the care of Dawgs in Motion LLC. Although Dawgs in Motion LLC screens all dogs for temperament, monitors the dogs carefully and turns away aggressive dogs, dogs still can be very active at times. We cannot be held responsible for injuries and/or death that may happen at Dawgs in Motion facility. The owner of the injured dog is responsible for all costs of veterinary care for their own dog.**
